What is BM-114

Magazine Ban

- Bans the possession of magazines and fixed feeding devices that can hold more than 10 rounds.
- Bans most tube fed shotguns will be banned, as they can hold more than 10 short shells.
- If suspected of having a high-capacity magazine or standard shotgun you would be arrested first, only then would you be given opportunity to prove you had the item/firearm before the ban (affirmative defense).

What is BM-114 (cont.)

Permit to Purchase

- A Permit to Purchase is required for all FFL transfers (gun store purchase, private sale, or a gift to a non-family member).
- Individual Local police and sheriff's departments will be responsible for funding, creating, and managing this permit program. No appropriations or budget has been established.
- A training course is required which includes a hands-on, live-fire session with a law enforcement certified instructor. Facilities do not exist (Estimated \$200M to build and \$40M annual to maintain). Staffing is short now (estimated 300 officers needed).
- No standardized curriculum for the training course, and Oregon Concealed Handgun License training does not meet the requirements.
- No standardization on permit requirements, local law enforcement can require "any additional information determined necessary."
- CHL holders will need to get a permit to obtain a firearm.

What is BM-114 (cont.)

Backlog Denial:

- If process is not completed in 30 days, for any reason (including if no action taken by officials), the application is categorically denied. Re-application is required at your cost.
- Current backlog is 6-7 weeks

Permit Registration Database:

- The Oregon State Police is directed by this measure to create and maintain a searchable electronic database of all permits.
- This data is not exempt from public disclosure. It can be published
- No funding or other resources allocated

Law Enforcement Officers

- Law Enforcement Officers are only exempt while on duty. Otherwise they must comply with the magazine and permit requirements.

Key Issues with BM-114 (cont.)

What IF Ballot Measure 114 passes:

- Considerable legislation is required to correct
 - This will be an uphill battle with administration with anti-gun agenda
 - It will take years!
- Expensive court challenges, once 'standing' is established.
 - Denied permit – due to lack of action in 30-day limit, facilities, process,
 - Denied permit – due to inappropriate requirements
 - 2nd amendment infringement due to biased and misleading administration of ballot process
- **Because of Ballot Measure 114:**
 - **LIVES WILL BE LOST**
 - Prevents actions to combat/prevent domestic violence, suicide,....
 - No impact on Criminals, or those with mental crisis.
 - Those with unlawful intent will not follow existing or new the law

- **Actions:**

- NRA/ILA has formed an Oregon Committee to post and drive NRA efforts
- OSSA/OASR will post an Opposition Statement in Voters Pamphlet (requires 750 signatures or \$1200, by Aug 30, 2022).
- Oregon Voters Digest session (video podcast), Op-Eds, Key publications, radio programs as possible.
- Educate Clubs and activate membership

- **What Can Your Club Do:**

- This is worth a special newsletter to members.
- Educate them – Activate them - Enable them to show their friends that this is just bad legislation.

If we, and all our friends, do not vote, it will cost lives, and we will lose our 2nd Amendment rights
